During his tenure in this position, League membership has grown from 87 to 121 members. He and his team manage the membership database and respond directly to member requests for information and assistance. He and his team also market and manage a suite of business programs and provide administrative oversight of The League’s unemployment compensation trust, U•COMP.

“I am honored to be able to serve our members in this new leadership role here at The League,” said Harry Krot. “I look forward to seeking out new ways to engage our membership, identifying resources and cost saving programs that assist them in meeting the challenges of the day and the future.”

Harry’s career has been virtually exclusive to working with or for Pennsylvania local governments. He has served as township manager in two communities. He has also held positions at the Pennsylvania Department of Community and Economic Development as a local government policy manager for the Center for Local Government Services and as the director of operations for the Community Development Block Grant program office.
